What data is collected?

- First and last name

What data is published on the website of the Gutenberg Museum?

- First and last name
- Profession or institution for which you work
- Your city / residence

Your e-mail address and the date of your signature will not be published.

How long will your data be stored?

Your data will be stored for an indefinite period of time to assure the archiving of all signatories. Your data will also be published on our website for an indefinite period of time.

What rights do you have?

Your consent to the publication of your personal data on our website is voluntary. You may revoke this consent to the Gutenberg Museum at any time, request deletion or demand that your data be corrected. You can also request information about the data stored about you at any time.

a) Right to information

You have the right to request confirmation from the person in charge regarding the processing of your personal data. If such processing has taken place, you have the right to request information on all processed data.

b) Right to rectification/completion

If you inform us that the personal data processed is incorrect or incomplete, we will correct or complete it immediately after becoming aware of it.

c) Right to cancellation

If you inform us that your personal data has been processed unlawfully, we will immediately arrange for the deletion of the data concerned. In the same way, data that is no longer required for the completion of the task at hand will be deleted. Please note the information on the storage period.

d) Right to limitation of processing

Under certain circumstances, you may request a restriction on the processing of your personal data. This may be considered, for example, if the person responsible no longer needs the data, but you need the data to assert, exercise or defend legal claims and deleting the data would harm your interests worthy of protection.

e) Right to object to the processing

You have the right to object to the processing of your personal data for reasons arising from your particular situation. In the event of an objection, we will no longer process your personal data, unless we can prove compelling reasons for processing such data that are worthy of protection and outweigh your interests, rights and freedoms. We may also continue to process your personal data despite your objection if this serves the assertion, exercise or defense of legal claims.

f) Right of complaint
